I purchased a Kissme dog from one of their buyers several years ago. I believe there was a medical issue and someone was handling things for the breeder in the interim. In any case, Kissme did not 'qualify' this buyer as a home/breeder and simply sold the dog with full registration. The buyer allowed her 60 lb male to breed this 32 female at something like 11 months, and then she just wanted to offload the pregnant dog. I was afraid she would go into the hands of a byb. I contacted Kissme before I went to meet the dog and got approval. I purchased her, whelped the litter, and found homes for all of the dogs at a financial loss to me - because the parents were not health tested. I did DNA testing on the mom, which was the maximum I could do on a pregnant dog. Afterwards, I spayed the momma dog and found her a forever home where she is loved and pampered and I still hear from her family today. Kissme refused to approve the litter registration and cut off communication. I provided extensive screen shots and documents from the buyer, and AKC did eventually register them.

I contacted my groomer who agreed to place her in a pet home. I thought that was done until Ms. Harvey contacted me telling me she was on her way to get Margot. At the time I was very upset & Margot was to be returned to me, as per my contract. I told Ms. Harvey that too.. Then I'm informed she's pregnant at 11 months old!!! With what was said to be an accidental breeding. Then later when she wanted me to sign off, I'm informed it's a witnessed breeding. I never stopped contact with her. We had several ensuing conversations. She couldn't take no for an answer. I wasn't willing to put my name on a litter that should have never been bred. Then she said she needed papers for these pups for buyers & I've learned she kept pups back from this breeding for herself. She wanted the akc papers it appears for all the wrong reasons. I'm still not happy about it. I told her this dog would not better the breed & should be spayed.

This is Missy. This dog has NOT been rejected many times. I got her back from the original owner, as expected, for this original owner was compliant and followed the contract. Margot did not meet my standards as a breeding bitch and should not have been bred. One of the people I partner with in poodles kept her while I was undergoing treatment and helped me find a home for Margot. She assured me that a questionnaire was performed and she felt she had found the perfect lifelong home. I thought Margot was sold on a spay/neuter contract. She should have never been bred. Margot does not meet the breed Standard. I did voice my opinion that Margot should have come back to me. You did not ask me in advance, you told me you were on your way to get her. Then you asked me if I had an issue with this. I told you that the dog should have come back to me. At that point, did it really matter what I

I absolutely do not condone this type of behavior-breeding dogs who should not be bred; not meeting the breed Standard and no health testing. I will not be listed as a breeder on this breeding. I have years of research and continuing education in this breed. I will not sacrifice that so that you can make a few extra bucks.

I have always worked to pay for my dogs, not the other way around and especially not this precious little girl who was a victim of humans. Poor girl had chunks missing from her shoulders that looked like the male bit and held on to her. And the little momma was spayed and placed - not used again to breed, because it was the right thing to do for her. I didn't choose "to make my money back" by breeding her again. I'm sure I could have worked my way through a few more litters with her if "making my money back" was the goal. Or perhaps I could have kept the female puppies, "to make my money back". I could have creatively marketed the puppies for the going standard poodle rate to "make my money back". There were a lot more ways to "make my money back" faster than studding my boy years later if that was the goal. Also, I was told she was cut because she had a gay tail - that it was attempted to be bred it out of the mother. Some breeders do not feel gay tail is an issue, especially overseas. I believe breeders have the personal choice regarding gay tails.
